About LIAISE

Editorial

The Network of Excellence LIAISE is entering its second year of activities, and this is a good time to summarize the progress towards the main achievements LIAISE is aiming to deliver: 1) a shared IA toolbox; 2) a shared research agenda on IA and 3) post-project durability, the continuation of the activities after the end NoE funding.

Shared IA toolbox

An extensive survey has been undertaken in 16 European countries among officers responsible for overseeing the process of IA in the respective jurisdiction. Together with a review of literature and an analysis of previous case studies of IA this gives an overview on user needs and expectations regarding IA processes IA tools, and IA training.

This is a key contribution to the design of the toolbox and the improvement of tools for IA. The basic design for the toolbox and a helpdesk have been discussed with the Policy Board. The modelling team of LIAISE has developed a reference model and analyses the requirements for IA tools. The toolbox and the models will be applied in test cases, which allow further feedback and learning Options for test cases have been discussed with the Policy Board and are now being implemented. A first one on the Finnish climate policy has been selected; two other ones - CAP and resource efficiency - are in preparation.

Shared research agenda

A mapping is undertaken on research projects for IA tools that received EC funding in FP6/7. This will be translated into research gaps. The inventory also includes information on the research institutions involved in this type of research, which are potential associated partners for the NoE. WP2 has established links with external scientific associations active in the field of IA research (e.g. IAIA) and presented LIAISE at several conferences. On these occasions, LIAISE has received considerable attnetion and several scientific organisations and conferences have expressed interest to host IA related working groups and sessions.

Post project durability

LIAISE aims to develop an enduring virtual centre of excellence for IA tools. This requires resources beyond the funding of the NoE. Here the main achievements in the first year of the project were:1) the development of a first version of the business plan for the future centre of excellence on IA with three preliminary business options; 2) the internal and external dissemination of information about LIAISE in order to strengthen the LIAISE profile in the communities of IA researchers and IA users; and 3) the development of synergy with IA research by external parties (e.g.

The activities mentioned above were accompanied by cross cutting activities: a dissemination strategy has been set up and is implemented (e.g. web page, newsletter), a Policy Board with members from different DGs, countries, and international organisations has been set up and held its first meeting in June.

A strategy has been developed to ensure the enduring commitment of the partners on an institutional level. All these activities led to many interactions: among the researchers in the network, with research communities beyond and with practitioners of Impact Assessment. We hope this newsletter indicates this spirit and you enjoy reading it

• 32nd Session of the Intergovernmental Panel on Climate Change

Busan, 11-14 October 2010. The approximately 300 participants focused on two primary tasks: revising the scope of the synthesis report (SYR) for the Fifth Assessment Report (AR5); and addressing the recommendations of the InterAcademy Council (IAC) Review of the IPCC processes and procedures. Progress reports were presented on the Special Report on Renewable Energy Sources and Climate Change Mitigation (SRREN), the Task Force on National Greenhouse Gas Inventories (TFI) and the IPCC Peace Prize Scholarship Fund. Berlin, 8-9 October 2010. The 2010 Berlin Conference, organised by the FU Berlin, was the 10th conference in the well established series of European Conferences on the Human Dimensions of Global Environmental Change. Several panels addressed the issue of IA, including papers on "Evidence-based Policy Making and Public Participation" (von Raggamby, Ecologic) which discussed the strengthening of environmental considerations in policy appraisal through participation, and on "Scientific Research in the Field of IA" (Podhora et al., ZALF) which presented the preliminary results of current LIAISE WP2 work on the scanning of existing IA tools on EU level.[READ MORE]

• Conference on increase of resource efficiency Berlin, 5 October 2010. "Resource Efficiency – Engine for Green Growth?" – this was the title of the final conference of the MARESS project ("Material Efficiency and Resource Conservation"), running from July 2007 to December 2010. At the conference, organised by the Wuppertal Institute, German Environmental Ministry and the Federal Environmental Agency, about 400 delegates from politics, economics, and science discussed the project results in five parallel panels. In panel V, Klaus Jacob presented the results of Impact Assessments on policies to increase resource efficiency of critical metals and discussed the resulting political challenges. [READ MORE]

Aalborg, 25-26 October 2010. "Climate change may be the biggest environmental challenge of our time. International consensus has formed around the problem, its causes and impacts but not the solutions. This special symposium will deal with solutions and actions to adapt to and mitigate the impacts of climate change. Innovative work on methodological developments, the institutionalisation of assessment methodologies, the construction of regulatory frameworks, and governance perspectives will be brought to the fore during the symposium. Together with IUCN, the ZALF hosts a session on 'Landscapes and Ecosystem Services'. This session will explore the use of impact assessment tools and of the ecosystem service concept for climate change mitigation and adaptation at landscape level." III IA and SD policy issues

Evaluation of the European Court of Auditors on the performance of the EU IA system

•The Court's audit found that, since 2002, the Commission has had a comprehensive impact assessment system in place. Impact assessment has become an integral element of the Commission's policy development and has been used by the Commission to improve the design of its initiatives. The audit identified areas for improvement related to the Commission's procedures in respect of impact assessments and the content and presentation of impact assessment reports. [READ MORE]

Public Goods Emerging as a Central Rationale for Future CAP Support

• Recent rhetoric at the Commissioner's conference on 20 July 2010, which assembled key stakeholders for a discussion surrounding the consultation responses, suggests that this reform could mark a significant shift in policy – particularly towards the use of public money to support the provision of public goods. In a briefing IEEP presents the concept of public goods and analyses how it is currently being used in the debate. [READ MORE]

EC consults further on indirect land-use change

• The European Commission is consulting on a series of recent studies on the indirect land-use change (ILUC) impacts of biofuels to find out whether the work produced so far is sufficient to assess the magnitude of the problem. Stakeholders are invited to comment on four studies, including one on the global trade and environmental impact of Europe's biofuel policy. The commission also wants to know if, based on the studies' findings, EU action is needed to tackle ILUC impacts [READ MORE]

Green groups urge greater support for HNV farms

• Four environmental groups have called on the EU to increase support for high nature value (HNV) farmlands as part of a reform of its Common Agricultural Policy (CAP). The call was made at a conference on HNV grasslands in Sibin, Romania this week. A report issued by the European Environment Agency in March showed that little CAP funding was being spent on supporting such farmlands, which could help to halt biodiversity loss: the majority of this funding goes to intensive farming activities...
