Editorial

The widespread diffusion of Impact Assessment (IA) has increased the need for a greater understanding of what affects the demand for and supply of impact assessment tools - such as computer-based models

supply of impact assessment tools - such as computer-based models and cost benefit analysis - amongst policy makers. But while there has been a strengthening of political commitment to improve the use of such tools in IA, both researchers and practitioners remain unclear as to which tools are used by whom and for what purpose. The conventional wisdom – informed by rather limited research – is that the use of IA tools differs quite widely between jurisdictions. Even when tools are embedded in a formal policy assessment system such as IA, their use is differentiated and often very limited, in particular when it comes to more advanced tools. So-called 'simple' tools appear to appeal more strongly to the everyday needs of policy makers than some of the more advanced and complex tools. Lack of time, data, some of the more advanced and complex tools. Lack of time, data, resources and skills are all factors which are thought to constrain the use of more advanced tools. Similarly, tools (such as modeling) appear to be used to understand the impacts of particular options, rather than to open up and explore a range of policy options (using scenarios for example). However, the overall picture of tool (non) use has not yet been fully explored.

LIAISE recognises that more information is needed on high level actors' perspectives - that is the perspective of those officials and other actors that are expected to develop, steer, evaluate and/or other actors that are expected to develop, steer, evaluate and/or undertake IA. LIAISE partners have therefore embarked on the most comprehensive survey thus far of user needs and expectations with regard to IA tool use. It is focusing on those involved with IA in their country at a strategic level (i.e. those people who champion, oversee, guide, audit or write guidance for IA processes rather than officials who carry out IA). Over 120 people in seventeen European countries have been included in the survey so far. Previous surveys of this kind have been either narrower in focus or in less depth. None have focused on the experience and insights of those people involved in steering IA at a strategic level in such depth. The report resulting from this survey will build both a broad and, at the same time, in depth account of user needs and expectations regarding IA processes, IA tools, and IA training. When these insights are put together alongside those of tool developers, it should be possible to reach a better understanding of how to achieve a better connection between the supply of and demand for tools; which is of course one of the strategic goals of LIAISE.

Public health impacts in URban environments of Greenhouse gas Emissions reduction strategies (PURGE)

FEEM will participate in this new research project just funded under the last EC-FP7-ENV call. PURGE will examine the health impacts of greenhouse gas (GHG) reduction policies in urban settings in Europe, China and India, using case studies of 3-4 large urban centres and three smaller urban centres. Sets of realistic interventions will be proposed, tailored to local needs, to meet published abatement goals for GHG emissions for 2020, 2030 and 2050.

 Vectors of Change in Oceans and Seas Marine Life, Impact on Economic Sectors (VECTORS)

FEEM is one of the partners of this new research project just funded under the last EC-FP7-OCEAN call. VECTORS will elucidate the drivers, pressures and vectors that cause changes in marine life, the mechanisms by which they do so, the impacts that they have on ecosystem structures and functioning, and on the economics of associated marine sectors and society.

DG Agri: The future of the CAP

• A Communication by DG AGRI is planned for November 2010. This Communication will prepare grounds for the legal proposals on the future of the Common Agricultural Policy (CAP), originally planned to be adopted by the Commission in July 2010. The impact of the economic crisis has been more severe than previously thought for EU agriculture, leading to a cumulative decline in agricultural income that erased in just two years the gains of the past fifteen. This development is neither related to the reform of the CAP, nor to developments in agricultural markets. On the contrary, it is directly linked to the way in which agriculture has been caught in the turbulence of the parallel boom and bust of all commodity markets in the aftermath of the financial crisis. It should be noted that the first phase of this communication does not require an Impact Assessment, but that IA will follow for the second phase entailling an SWP and Legal Proposal in July 2011. DG Enterprise & RTD: Research and Innovation Plan

• The Europe 2020 strategy for smart, sustainable and inclusive growth announces the presentation of the Research and Innovation Plan in particular to implement the flagship initiative "Innovation Union". One of the central problems identified is policy fragmentation and the role of instruments, an issue that is at the heart of LIAISE. At EU and national level, and between EU and national policies, policy fragmentation leads to sub-optimal impacts of the different instruments and lack of critical mass. The articulation between the R&D Framework Programmes, the Structural Funds and the Competitiveness and Innovation Programme is still underdeveloped in terms of coordination, synergies, efficiency and simplification. This is increasingly seen as an import deficit in realising coherent policies within the framework of the knowledge triangle. [READ MORE]

European Tourism sector as one of the actions of high importance. • In the light of the EU's failure to achieve its target, a mid-term assessment report of the BAP carried out in 2008 (COM(2008) 864), which represented the last opportunity for stock-taking before 2010, presented a detailed picture of the state of implementation, highlighting the need for more action. The post-2010 Communication is due for the 4th quarter of 2010 and aims at many economic sectors and social groups depending on the sustainable use of biodiversity, addressing economic operators who may have an impact on biodiversity and several EU policies that have a direct bearing on biodiversity. The existing roadmap document makes several references to impact assessment. [READ MORE]
