EDITORIAL by Klaus Jacob, FUB and Jacques Jansen, ALTERRRA. Impact Assessment remains high on the agenda of the European Commission as several recent publications underlined: The report of the European Court of Auditors with its evaluation of the IA practice, the Impact Assessment Board Report for 2010 or the publications of the <u>roadmaps</u>. A LIAISE survey among ca. 130 experts from 17 countries revealed a high interest in the topic also in the member states. The <u>study reveals</u> that the use of methods and models to support IA is not fully exploited and that the tool use is highly dependent on the context in which they are applied. The Network of Excellence LIAISE aims to live up to the expectations on IA. During the annual meeting hosted by Fondazione Eni Enrico Mattei in Milan on 26-28 January 2011, the achievements of the first year of activities were reviewed. The members of the network renewed their commitment to its joint strategic goals: 1) to develop a shared toolbox, 2) to develop a shared research agenda and 3) to ensure the durability of activities beyond the funding of the network. All the activities of the network contribute to these goals by improving the understanding of the tools, by testing them and by increasing their use. The goal of an improved and adequate use of the tools cannot be achieved in laboratories only. An intensive science-policy dialogue is necessary. On February 1st LIAISE presented its results after the first year of the project at a Policy Board meeting in Brussels to 9 representatives from the EC, EU Member States and the OECD. This second meeting in the science-policy interface on IA tools showed a lively interaction between the communities of IA practitioners and IA researchers around the key question: how to enhance the use of scientific knowledge and tools in Impact Assessments in policies aiming at the implementation of the renewed EU Sustainable Development Strategy. The Policy Board meeting was followed by a round table discussion attended by an additional number of EC officials and other stakeholders interested in IA. The ca. 40 participants discussed the assessment of social aspects, the participation of stakeholders in IA, the assessment of impacts at the national and subnational level and the need for an improved interaction of science and policy on the mid- and long-term planning of policies and scientific capacities.

LIAISE News

LIAISE Annual Meeting

LIAISE had its second Annual Meeting from 26 to 28 January, 2011 in Milan, Italy. About 60 LIAISE colleagues exchanged information and discussed on topics related to the LIAISE strategic goals, i.e. the Shared IA Toolbox and Research Agenda and the transformation of the Network of Excellence into a durable Centre of Excellence. The presentations and discussions made very clear that we covered a lot of ground in the 1st year. Many activities have been completed and new ones started. Good progress has been made and LIAISE is now well established. The level of integration, the willingness and commitment of the LIAISE partners to combine resources and the many links with the IA practioners on European and Member State level is impressive.

Meeting of the LIAISE Policy Board

The LIAISE Policy Board met in Brussels on 1 February, 2011 to discuss the progress and achievements of LIAISE and to provide recommendations for the next steps. The board is composed of experienced officers and experts in Impact Assessment from European institutions, the OECD, member states and think tanks. It is chaired by Jérôme Vignon, former director in DG EMPL of the European Commission. The members of the board discussed possible extensions of the LIAISE competences to cover social aspects. The members also recommended to extend the services of LIAISE also to IA of the member states and to design test cases and the tool box accordingly. The post-funding activities of LIAISE should be closely linked to the activities and priorities of DG RTD and the JRC.

LIAISE Round Table Discussion

Febrary, 2011 the LIAISE team invited in Brussels for a first public round table discussion on the future of Impact Assessment in Europe. Ca. 40 participants from different European institutions and stakeholders took part in the discussion. The topics were, inter alia, the participation of stakeholders in IA, the involvement of Member States and their practices in IA and the assessment of social impacts. A general conclusion was that – since the contextual conditions are crucial for the use of scientific IA methods and tools – the use of IA in evidence-based policy-making can greatly benefit from a more direct and a more institutionalised interaction between IA researchers and IA practitioners.

Library of IA case studies

This library, developed jointly by the LIAISE Network of Excellence and the ALREG project contains summaries of many case studies of IA. An IA case study is 'a report on a specific process of IA with a narrative - analytical structure', organised by several variables such as tools used, role of consultation and timing in the policy process. Material for the case studies is drawn from a variety of 'sources', including several FP funded projects. They cover IAs undertaken in the European Commission and different EU and non EU states

• LIAISE Innovation Report No. 2. 'Impact Assessment Practice in Europe'

The second issue of the LIAISE Innovation Report on 'Impact Assessment Practice in Europe' is out at the beginning of the second year of the LIAISE project. It includes an article by Camilla Adelle (UEA) on 'User Needs in Impact Assessment' that summarizes the most comprehensive survey yet conducted of tool use and user needs in 17 European countries, which was done as part of the LIAISE project. In addition to the research article, the Innovation Report briefly reviews a number of recent and interesting publications on IA.

Germany is still in the beginning with its SIA: Two years ago, Germany extended its legal / regulatory impact assessment by an obligatory SIA component.

ECA Special Report no. 3/2010: Impact Assessments in the EU Institutions - Do They Support Decision-Making?

The European Court of Auditors released a special report on Impact Assessment in the EU institutions and assessed whether the Commission's IA supported decision-making in the EU. The audit reviewed the periods from 2003 to 2008 and involved a comparison of the Commission's IA system with other systems elsewhere. It examined to which extend the Commission, the European Parliament and the Council consulted IAs when formulating policy proposals. Moreover, the report assessed, if the IAs appropriately supported the development of the Commissions initiatives and whether the content and presentation of the findings was beneficial for being taken into account for decision-making.

EC to launch resource efficiency drive

EC to launch resource efficiency drive The European Commission has announced to publish its flagship initiative on resource efficiency by 26 January. It will be followed by a roadmap to describing the vision of a more resource-efficient economy in 2020 and 2050, it will propose new policy initiatives that enhance synergies between policies, in particular to stimulate greater innovation for short-term and long-term economic and environmental benefits. The study, Conducted by Bio Intelligence Service, concludes that though considerable progress has been made, there are wide disparities across the EU. For example, Germany and the UK have reached absolute dematerialisation, though through deindustrialisation; in Spain, resource use is growing faster than GDP.

This updating round adds a significant amount of marine areas to the Natura 2000 network. A total of 17 marine sites have been added, covering more than 17,500 km². EEA Report on Consumption and the Environment

EEA Report on Consumption and the Environment The European Environment Agency (EEA) released its fourth Environment State and Outlook report. Consumption and the environment is one thematic assessment therein. The assessment reveals that the consumption of goods and services in EEA member countries is a major driver of global resource use and associated environmental impacts. Food and drink, housing, mobility and tourism are responsible for a large part of the pressures and impacts caused by con-sumption in the EU.

Impact Assessment Board Report for 2010

The Impact Assessment Board published a report on its work from 2010. It evaluates recent developments in the IA system, examines the quality of Impact Assessments and gives recommendations for further improvement. The IAB reviewed 66 IA reports and issued 83 opinions.
